A. In the "price" criterion the highest number of points (80) shall be given to the tender offer with the lowest net price, and each of the subsequent offers in accordance with the formula:

P - number of points for the criterion Cmin - lowest price among the proposed

C - price in the tender offer

Z - weight of the criterion.

- B. In the "The term of the warranty service" criterion of the offer will be able to obtain the following points:
 - below 24 months = 0 points
 - from 24 months to 35 months = 5 points
 - over 35 months = 15 points
- C. In the "Costs of post-warranty service" criterion the valuation of service for 1h of work along with the costs of the technician's travel. The points shall be awarded after the calculation in accordance with the formula below:

 - b. holding at least 10% of shares or stocks,
 - c. the performance of a member of the supervisory authority or management, proxy, representative,
 - d. marriage, cohabitation relative by blood or affinity in a straight line relationship or affinity in the collateral line to the second degree or relation of adoption, care or custody.
